With help from another German partner, INIT USA, TQ Systems now has a home in Chesapeake, and is well on its way to ramping up production and creating numerous jobs. Givens, Inc. invests an additional \$30 Million for Expansion in Greenbrier North Commerce Park

Givens, a company doing business in Chesapeake since 1970, is expanding operations by investing \$30 Million in two (2) new distribution centers in Greenbrier. Givens has over 340 employees in Chesapeake and offers a full spectrum of transportation, warehousing and logistics services; specializing in the demanding requirements of automotive, mass merchandise and electronics distribution.

The two new facilities will be approximately 100,000 square feet each and located on an approximately 17-acre parcel in the Greenbrier North Commerce Park. The new buildings will add to the over 1.6 million square feet of warehouse space at the company's six (6) main distribution centers in Chesapeake. All of Givens' buildings are custom-designed to efficiently meet the modern, fast-paced distribution requirements in a secure, high-volume, high-capacity environment. In addition the company operates one of the busiest FTZs in Virginia with over 60 international accounts.

Baylor

Baylor Management Corporation Constructs Speculative Space in prporation Greenbrier North Commerce Park

The Baylor Corporation has purchased an approximately 9-acre parcel in the Greenbrier North Commerce Park to construct an industrial condominium complex. Baylor Corporation will develop eight (8) 10,000–12,000 sf speculative industrial buildings for lease or purchase.

The Baylor Corporation is an institutional property investment and management firm located in Norfolk. The Greenbrier North project will make an excellent location for small to medium size operations that will allow low start-up and operational costs.

Mitsubishi Chemical Composites MITSUBISHI CHEMICAL America Expands Manufacturing Facility

As one of the first companies to invest in the Greenbrier area more than 28 years ago, Mitsubishi Chemical Composites America (MCCA) is one of the largest employers in Chesapeake. In 2019. MCAA announced its plans to enlarge their APOLIC[®] production facility to add approximately 40,000 square feet to the current plant footprint. The nearly \$5 million investment will allow MCCA to increase its storage, shipping, and receiving capabilities. The expansion will add 30 full-time manufacturing positions. MCCA is part of the global Mitsubishi Chemical group of companies. MCCA has manufactured APOLIC[®] Metal Composite Materials (MCM) since 1991 at its Chesapeake location off Volvo Parkway.

Burns & McDonnell Expanding MSDONNELL Footprint in Chesapeake

Burns & McDonnell, a full-service engineering, architecture, construction, environmental and consulting solutions firm, is expanding its presence in Chesapeake. The company will occupy 25,000 square feet of office space at 1317 Executive Boulevard in the Liberty Executive Business Park. The company will create 50 new jobs and invest \$1.5 Million to open the new Class A office space that will accommodate 120 Architecture Engineering and Construction (AEC) professionals. The employment growth at this new location is part of an overall Mid-Atlantic expansion across the entire state. The expansion demonstrates the company's long-term commitment to growth in Chesapeake and further demonstrates the strength of the Professional Business Services sector in the City of Chesapeake.
